CONSTITUTIONAL RESERVATION

- 1) The candidates recognized by the State of Maharashtra as belonging to the following Backward Classes, shall alone be eligible to claim admissions as against the seats reserved for such backward class categories. The constitutional reservation at Government/ Corporation Institutes and Private unaided Institutes is as mentioned below.

 - iii. **SEBC (Socially & Educationally Backward Classes) Reservation:** In Government / Corporation / Private Unaided Institutions, 10% seats of the available seats shall be reserved for candidate belonging to SEBC category. This reservation will be subject to outcome of W.P. No. 3468/2024 in Hon'ble High Court Mumbai and any other future court cases in this regard. **(Annexure "W")**
- 2) Candidates belonging to aforesaid Backward Class categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate at the time of documents verification. (Reference Hon'ble Supreme Court Order 06/092017 Annexure -K). As per Govt. of Maharashtra G.R. No. Misc.-2024/C.R. 75/Reservation-5 dated 22nd July 2024, candidates belonging to SEBC Category can produce his/her Caste Validity certificate upto six months from the date of application for admission to the Health Science Courses, failing which his/her admission will stand cancelled and he/she will be responsible for the same **(Annexure – JJ)**.

This reservation will be subject to outcome of W.P. No. 3468/2024 in Hon'ble High Court Mumbai and any other future court cases in this regard. **(Annexure "FF")**
- 2) Candidates belonging to aforesaid Backward Class categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate. As per Govt. of Maharashtra G.R. No. Misc.-2024/C.R. 75/Reservation-5 dated 22nd July 2024 and As per Govt. of Maharashtra General Administration Department No. - Code-2024/P.No. 75/Reserve-5, dated 5th September, 2024 candidates belonging to SEBC & OBC Category can produce his/her Caste Validity certificate upto six months from the date of application for admission to the Health Science Courses, failing which his/her admission will stand cancelled and he/she will be responsible for the same **(Annexure – FF & Annexure – HH).**
