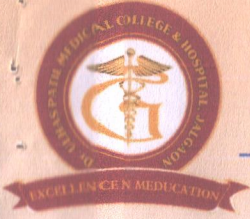

1. Awareness about Anti-Ragging:

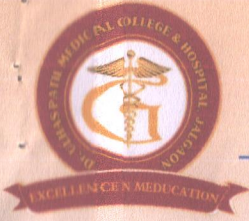

Agenda:

To sensitize students about the National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021 and to distribute informational pamphlets to raise awareness and promote compliance.

1. Mr. Pramod Bhirud, the Registrar and a committee member, introduced and briefed the members of the Anti Ragging Committee to the all PG students. He also explained the seriousness of ragging and its negative impact on students.
He spoke about the awardable punishments outlined in the NMC Regulations, 2021, emphasizing the critical need to establish a safe and healthy environment for all students. He underscored that such measures are essential for promoting student well-being and upholding the integrity of the educational experience. His remarks were intended to reinforce a steadfast commitment to maintaining a supportive academic atmosphere where students feel secure, respected, and valued.
2. Dr. N S Arvikar, Medical Director, and committee member, addressed the students and informed them about the punishable ingredients of the National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021. He stressed the importance of following these regulations and warned the students about the consequences of ragging.
3. Dr. Prashant Solanke, the Dean, recently clarified the definition of ragging and its associated punishable consequences. He emphasized the importance of fostering a supportive environment where juniors are mentored by seniors, promoting a positive and respectful atmosphere within the institution. This approach aims to prevent any form of harassment or intimidation and encourages healthy peer relationships, upholding the institution's commitment to student welfare and discipline.
4. Information pamphlets were distributed to all the students, which contained details about the regulations, consequences of ragging, and contact information of the Anti Ragging Committee members.

5. The meeting ended with a vote of thanks to the chair.

The Anti Ragging Committee members will ensure that the students follow the regulations.












2.1 Inaugural Ceremony.

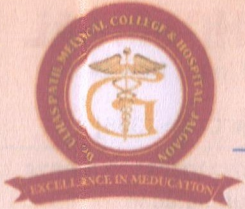
- An inaugural ceremony to mark the Anti-Ragging Day and the commencement of Anti-Ragging Week will be organized. Details of the event and invitees to be finalized by the organizing committee.

2.2 Competitions.

- Various competitions such as slogan writing, essay writing, poster making, and logo designing on anti-ragging themes will be held at the college level.
- Certificates and prizes will be awarded to the winners to encourage participation.

2.3 Awareness Campaigns.

- The college will actively disseminate anti-ragging messages via its official website and social media platforms.
- Hoardings and banners promoting anti-ragging will be displayed prominently within the campus.

3. Complaint Box Update.

- The status and usage of the complaint box were discussed.
- It was decided to regularly monitor the complaint box to ensure timely action on grievances.
- Awareness about the complaint box will be increased among students to promote reporting of ragging incidents.

4. Anti-Ragging Preparations Before Admission of First-Year M.B.B.S. Students.

With the objective of providing every new student a **safe, respectful, and ragging-free environment**, pre-admission anti-ragging measures are being strategically planned and effectively implemented in the college. The following points are included in this preparation:

- Posters describing the penal provisions and the provisions of these rules have been prominently displayed in the college premises, hostels, libraries and canteens.
- The fresher's shall be counseled to prepare them for the life ahead, also involve parents and teachers in the counseling sessions.
- A joint sensitization program will be organized for fresher's and senior students to provide information about what ragging is, its types, and legal consequences.
- It is mandatory for students and parents to submit an anti-ragging affidavit in accordance with UGC and NMC regulations. This affidavit must be filled and submitted online.
- The Anti-Ragging Squad Committee will conduct surprise inspections of the hostel, conduct anonymous surveys and strictly enforce disciplinary measures.
- Anti-Ragging Committees (Anti-Ragging Committee, Squad, and Mentorship Committee) have been activated as per a predefined structure. The names,

- Fresher's shall be lodged, as far as may be, in a separate hostel block or wing and the medical college.
- Measures will be taken in the form of cultural and sports activities to promote joint interaction between freshmen and senior students.

- Publicity team to prepare promotional materials for competitions and awareness campaigns.
- Administrative team to ensure proper display and maintenance of hoardings, banners, and complaint boxes.
- IT team to provide students easy access to the UGC and Anti-Ragging.

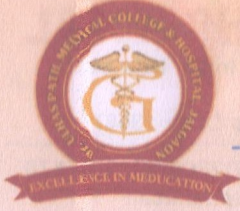
