In continuation to this Ministry' letter of even number dated 30.03.2015 and your letter No. GF/DUPMCH/UG-Increase/2015/118 dated 15.04.2015 furnishing required undertaking and Bank Guarantee in favour of Medical Council of India, I am directed to convey the formal permission of the Central Government to your college for increase of MBBS seats from **100 to 150** for the academic session 2015-16- under Section 10(A) of the IMC Act, 1956.

2. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to the verification of the achievement of annual targets as indicated in your scheme and revalidation of performance Bank Guarantee. This process of renewal of permission will continue till such time the infrastructures and expansion of hospital facilities are completed as per norms of Medical Council of India. The next batch of students shall not be admitted unless renewal of permission is granted by the Central Government.
3. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.
4. Discrepancies, if any, may be brought to the Notice of MCI and Central/State Government.
